## LICENCE AGREEMENT FOR REPRODUCTION OF IMAGES

The terms “Licensee”, “Purpose”, “Image”, “Medium”, “Print-run”, “Term”, “Period of Hire”, “Territory”, “Product” and “Fee” shall have the meanings attributed thereto in the Schedule hereto.

### Licence

Upon payment of the Fee by the Licensee and execution of this Licence Agreement by both parties, the NGI hereby grants a non-exclusive licence to the Licensee to reproduce and publish the Image STRICTLY so as to:

- produce the Product;
- in the Medium;
- for the Purpose;
- in the Territory;
- during the Term; and
- in a number of copies not exceeding the Print-run.

Any reproduction or dissemination of the Image which exceeds these parameters is not authorised by this Licence and shall be actionable at law.

### Image Hire

To enable the Licensee to reproduce the Image, the NGI shall (subject to availability) hire the Licensee a transparency or compact disc carrying the Image. The Licensee shall base the reproduction of the Image solely on the transparency or disc supplied by the NGI. It is strictly prohibited to make duplicates of the transparencies or discs. The Licensee may retain the transparency or disc for the Period of Hire only, and must return it in good condition before the expiry thereof. Late returns will attract an additional fee of €20 per week for up to two months, after which time the transparency or compact disc will be considered lost. In the event the transparency or compact disc is lost, destroyed or damaged, the additional fee will be €350, which sum shall be accepted by the NGI in discharge of the Licensee’s obligation to return the transparency or disc.

### Copyright

The Licensee undertakes to refrain from any breach or infringement of copyright in the Image, including the moral rights of the artist, and shall indemnify the NGI against any such breach or infringement.

Copyright in the photography of the Image is vested in the NGI, unless otherwise stated. All reproduction of the Image by the Licensee must include the acknowledgement “Photograph courtesy of the National Gallery of Ireland”, along

with the name and dates of the creator and the title of the work reproduced in the Image, as supplied by the NGI.

The reproduction and dissemination of unpublished images, and of images created by artists who are living, or dead less than 70 years, requires the consent of the copyright holder in addition to the licence of the NGI. Such consent must be obtained by the Licensee.

The Licensee acknowledges that no rights whatever in the Image shall accrue to the Licensee by virtue of any use thereof by the Licensee. In the event that any such rights should inadvertently be acquired the Licensee unequivocally assigns the same to the NGI, and if required, shall execute any further assignment which may be required by the NGI.

### **Use of the Image**

The Licensee must reproduce the Image faithfully, and may not manipulate, mask out, cut down, superimpose with other material, or in any way distort or alter the Image, or any part thereof. Application to reproduce a detail may be considered only upon receipt of a sketch showing the area to be reproduced. Reproductions of details must be captioned "DETAIL".

All reproductions of the Image produced by the Licensee shall be of good quality and shall be published in a manner and context which is not prejudicial to the interests or reputation of either the NGI or the artist.

The Licensee shall use the Image in a lawful manner and for lawful purposes only, and shall indemnify the NGI against all claims, damages, loss or expenses arising from any third party action concerning the use of the Image by the Licensee. The NGI shall not be liable for any loss or damage suffered by the Licensee in connection with the use of the Image by the Licensee.

A complete copy of the Product must be made available to the NGI within one month of production.

### **Termination of the Licence**

The Licence herein contained shall be immediately revoked, and this agreement terminated by the NGI in the event of breach of any of the terms herein contained by the Licensee. Termination shall be without prejudice to any antecedent claim on the part of the NGI.

### **Applicable Law**

This Licence is governed by the laws of Ireland, whose courts shall have jurisdiction in the event of any disputes.
